#### **MYTHS**

## Highlights for 2021

- Individuals living at the Dakota City site moved to the Humboldt Site February 1. The landlord felt the building in Dakota City was better suited for families, since it had three bedroom units with two bathrooms. Tenants were not offered renewal leases, but were given new leases at the Humboldt Site instead.
- LifeWorks achieved goals from the last strategic plan! All overall stakeholder satisfaction was maintained above 80%. Billing efficiencies were realized. Compensation to Direct Support Professionals increased. The Supported Employment Program grew. A new three-year plan was written. New goals include continuing to increase Direct Support Professional wages; growing non-residential services; increasing the use of technology, in both services and in the business office; and maintaining satisfaction above 80% for all stakeholders.
- In response to the pandemic and growing Day Habilitation referrals, LifeWorks remodeled some former workshop space in Fort Dodge.
- LifeWorks leased space to One Vision at the Fort Dodge vocational site. Services and rules have changed in the meanwhile, so One Vision (OV) does not need the space they once did. OV made the decision to move offices to a different location effective June 1, but continue leasing warehouse space. LifeWorks will continue leasing space to Freedom Pointe of Greater Webster County.
- On July 1, LifeWorks' home Mental Health/Disability Services Region will change from County Social Services to Central Iowa Community Services.
- Reviews, audits and certifications for 2021 include the Department of Human Services' Home and Community
  Based Services certification occurring now, Social Security's audit of the payee program, the annual business
  office audit to transpire in the late summer, and a CARF review anticipated for this fall.
